4	The school has reported 3 building blocks.Ramp at the entrance of only 1 building is seen.No ramps/lifts for CWSN to access the upper floors are seen .The school shall construct the ramps at the entrance of all building blocks and construct ramps/install lifts in all building blocks for CWSN, as per norms of RPwD Act and guidelines issued by the Board and submit compliance on SARAS within 3 months.			
5	As per IC report, the school has applied for renewal of Fire Safety certificate. the school is directed to upload the renewed Fire Safety certificate on SARAS portal within next 3 months.			
6	The school has 3 building blocks and is multi storied, but has reported only 1 CWSN toilet each for CWSN.The school shall construct separate toilets for CWSN, boys and girls on every floor as per norms of RPwD Act and guidelines issued by the Board and submit compliance within 3 months on

7	The school shall conduct training of its teachers with CoE Chennai within next 3 months and submit the compliance.	
8	The school shall create a separate reading area for teachers in the library and submit compliance within 3 months on SARAS. The school is advised to follow the SoPs issued by the Board in respect of labs, library and sports facilities.	
9	The school shall get all the mandatory certificates renewed periodically.	
10	The school is directed not to remove the mandatory disclosure section from its website and the videography link of the inspection /infrastructure from YouTube.
