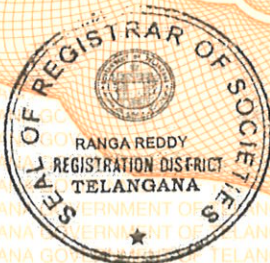

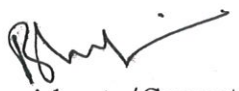
3. AIMS AND OBJECTS.

- c. Certified that the Society would not engage in any illegal activities.

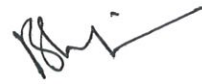

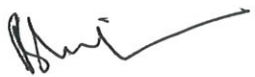
1. NAME OF THE SOCIETY: Pallavi Gandipet School (PGS) Parents Teachers Association.

PREAMBLE; -

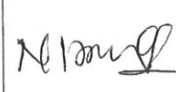
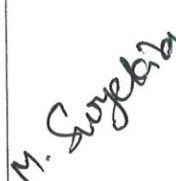

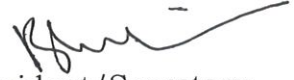

Secretary: - Ensure the PTA runs smoothly and provides a link between the PTA, school and the wider community, deal with the correspondence for the PTA and liaise with the school Secretary.

Joint Treasurers: - Maintain up-to-date records of all PTA financial transactions.

Funds: - The Funds shall be raised from donations, contributions and membership entry fee and no person shall be paid or transferred directly or indirectly to any of members through any means. Any surplus funds available with society shall be invested in such modes as may be specified under section 11(5) of income tax Act as amended from time to time.

Bank account: -

A bank account shall be opened in the name of society and the same shall be operated by such of those designated office bearers.

The funds of society shall be deposited in the name of society in nationalised or schedule Bank chosen by the principal and Secretary.

The funds of the society constitute from donations, given by the general public, staff, teachers and parents, subscriptions from the members, fee or remuneration collected from the users of the service of the society.

Amendments: -

No amendment or alteration be made in the aim and object of association any other amendments shall be made unless a majority of 2/3 members of the association.
