- The Management should follow the provisions of the Telangana Education Act, 1982; G.O.Ms.No.1, Education (PS.2) Department, dt.01.01.1994, as amended from time to time and Compulsory Teaching and Learning of Telugu as per the provisions of the Act No.10 of 2018, dt.30.03.2018, which came into force from 02.04.2018 and the connected Rules to this Act issued vide G.O.Ms.No.15, School Education (Prog.II) Department, dt.01.06.2018. The Government have also prescribed the books to be introduced for Classes I and VI which have to be followed for the Compulsory Teaching & Learning of Telugu language as per this Act 10 of 2018 & the connected Rules.
